**O. REVIEW SB POLICY 3612 - DISTRICT PROVIDED ACCESS TO ELECTRONIC INFORMATION, SERVICES, AND NETWORKS – COMPLIANT WITH CIPA (CHILDREN’S INTERNET PROTECTION ACT)**

This is public hearing required by Children’s Internet Protection Act. School Board Policy 3612 adopted in 2000, addresses the required policy. From the policy the District Internet Agreement was developed which is signed by all student and parents. Additionally, the District uses Lightspeed content filter to prevent access to inappropriate sites. One additional requirement has arisen in the past few years is cyber bullying. We restrict access to most social network sites to help curb this problem.

Motion by Clayton Talks Different to reaffirm SB Policy 3612 and approve the existing District Internet Agreement. Second by Johnathan Walker and motion carried 4 for, 1 absent (Doney).
